 The certificate of competency issued in favour of a person shall stand cancelled if the person declared competent leaves the organization mentioned in his application.

4) The institution recognized as a competent person shall keep the Director, Industrial Safety & Health informed of the names designations and qualifications of the persons authorized by it to carry out tests, examinations and inspections.

3) The copies of certificates of examinations / tests issued by you after due examinations / tests are for semantics to the impector of Factories concerned within seven days in all cases where defects are noticed and repairs or alternations are suggested on its use.

The record of the work done by the competent person should be maintained in the Log Book, incorporating therein the details regarding work done, observations made, directives given etc.

Certificate No. and validity period—should invariably recorded by you in all the copies of certificates of examinations / tests signed and issued by you.

8) Every examination i test shall conform to the relevant standard, if it is not specified in the Act or rules made there under.

Practitives and equipments to be used by you should be maintained and kept in a good and efficient working conditions at all times and calibrated from time to time.

Application for renewal of Competent Person Certificate shall be made at least two months before the date of expiry of the certificate to the Director, Industrial Safety & Health with Log book for the period of previous nine months in case of first renewal and twelve months in case of second and subsequent renewal.

Save as provided in Rule 61(9)(a) of section 31, in no case conditional certificate shall be issued.
